WHAT DOES RAM PAYMENT, LLC DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> ■ Social Security number and checking account information ■ Account balances and account transactions ■ Transaction or loss history and credit card or other debt <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons RAM Payment, LLC chooses to share; and whether you can limit this sharing.

What we do	
How does RAM Payment, LLC protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does RAM Payment, LLC collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> ■ open an account or make payments ■ tell us where to send money or give us your contact information ■ provide us with your financial account information We also collect your personal information from other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> ■ sharing for affiliates' everyday business purposes—information about your creditworthiness ■ affiliates from using your information to market to you ■ sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ■ Reliant Retention Services, LLC, and RAM Payment, LLC d/b/a Reliant, including Reliant Account Management
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ■ RAM Payment, LLC does not share with nonaffiliates for their marketing purposes
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> ■ RAM Payment, LLC does not engage in any joint marketing activities
Other important information	
<p>Do Not Call Policy: Unless permitted by law, we do not solicit market to telephone numbers listed on state or federal Do Not Call lists. Consumers who ask not to receive telephone solicitations from Ram Payment, LLC will be placed on our internal Do Not Call list and will not be called in future marketing engagements, including those of RAM Payment, LLC affiliates.</p> <p>California/Oregon: The privacy laws in effect in these states do not apply to certain information, such as personal information subject to the Gramm-Leach-Bliley Act or the Fair Credit Reporting Act, or subject to other exemptions. For example, they do not apply to personal information that we collect about consumers who seek or use the financial products and services which are subject to our Privacy Notice.
